## CONNECTIONAL FUNDING IN THE GLOBAL METHODIST CHURCH

In the Global Methodist Church, local congregations will not receive a connectional funding bill from either the Global Methodist Church (GMC) or the Annual Conference. Instead, a local church calculates the amount it will give for connectional funding and then, on a monthly basis, sends a portion of that amount to the general church (GMC) and also a portion to their Annual Conference. Thus, there are two categories of connectional funding—one for the general church and one for the Annual Conference. The following information will guide you through that process.

Connectional funding is addressed in ¶449 of the *Book of Doctrines and Discipline*. The Global Methodist Church has set general connectional funding at one percent (1%) of a local church's operating income. **For 2025, the Northeast Annual Conference rate will remain at three percent (3%), as approved by the Conference Connectional Council.**

### DETERMINATION OF CONNECTIONAL FUNDING AMOUNT

Your local church financial designee will calculate the amount to be given, based on your local church's **prior year** operating income. This means that for 2025, the calculation is based on your 2024 operating income.

- Operating income is defined in ¶449.4 and ¶449.5. Specifically, ¶449.4a states that local church operating income includes (see some examples below):
  - Giving from identified and unidentified donors
    - Tithes
    - Offerings (unrestricted)
  - Investment income utilized for operations
    - Interest
    - Dividends
  - Building use fees and rental income

➤ Other unrestricted operating income

Fundraisers

To report these amounts:

1. Enter the data in the appropriate cells listed under “Included in Operating Income” on the worksheet.
2. The worksheet will automatically calculate “Total Operating Income” once the data is entered.

¶449.4b outlines the types of revenue that should be *excluded* from local church operating income. These exclusions include:

- Benevolences (outside ministries supported by the local church)
- Capital campaign receipts
- Borrowed funds
- Fundraisers for non-operating expenses
- Receipts for reduction of indebtedness
- Memorials, endowments, and bequests (whether restricted or non-restricted)
- Receipts for Global Methodist Church special mission programs
- Grants and support from other organizations
- Sales of land, buildings, or other church assets
- Other non-operating income received

Income from these sources should not be included in the categories that constitute operating income on the worksheet. (See Examples of What IS and IS NOT Operating Income [HERE](#).)

The worksheet automatically calculates the local church’s “Yearly Annual Conference Connectional Funding” (Row 21). The worksheet then calculates the local church’s monthly payment for General Church Connectional Funding (Row 19) and Annual Conference Connectional Funding (Row 22).

Each January a local church financial designee (i.e., treasurer) is asked to complete a new Connectional Funding Worksheet to determine Connectional Funding remittances to the Global Methodist Church and the Northeast Annual Conference.

Payment of your connectional funding by electronic (ACH) is beneficial not only to the Northeast Annual Conference, but also to your church. Since the amount of the payment does not change from month-to-month, paying electronically allows you to set up recurring payments once per year rather than expending the effort to generate and mail a check each month. Local churches can send more than one month's payment at a time, however, we encourage local churches to send connectional funding payments on a monthly basis. Please complete this [Electronic Remittance Form](#) for electronic payments through Realm, your bank, or when using a third party vendor to mail a check.

We look forward to receiving your local church's connectional funding giving and sharing with you the fruits of our connected ministry.

1. Within the first few weeks after receiving this document, please complete the [Connectional Funding Worksheet for 2025](#), scan to an electronic file, and email to the Conference Treasurer, Erika Renwick, at [treasurer@northeastgmc.org](mailto:treasurer@northeastgmc.org).
2. When you are ready to make your first month's connectional funding payment, either:
  - Set up your electronic ACH giving account through the [Realm portal](#) and submit your monthly or recurring payment. Use [this form link](#) to notify the Conference of any electronic payment (including bank and third party vendors).
